The meeting was called to order at 7 pm by Chairman Meyer.

Roll Call was taken with ten (10) members present.

The meeting being duly posted and a quorum present, the Chairman proclaimed this meeting to be a legal meeting and acknowledged that the Open Meeting Act was posted in the meeting room.

Motion by Wade Neben and seconded by Joseph Smith to approve the agenda. Ayes (10) Nays (0) Abstain (0).

Motion by Diana Hurlburt and seconded by Joseph Smith to approve the May 28, 2024 Minutes. Ayes (8) Nays (0) Abstain (2).

Motion by Jack Van Slyke and seconded by Dave Larson to approve the May 2024 Financial Statement. Ayes (10) Nays (0) Abstain (0).

# Towers & Equipment Report:

- a. The Next Gen 911 equipment cutover happened on June 12<sup>th</sup> with Motorola, Emergency Call Works, Platte Valley Communications and Applied Connective here to assist for a smooth transition. The 911 lines were rolled to Custer County during the transition. Virginia did all the continued call testing throughout the day. There was continued tweaking through the next week to iron out a few configuration issues.
- b. The radio and paging backup console was discussed with the cost and line charges.
- c. The agreement with Stealth Broadband for space on the Greeley tower was brought to the board. More information will be brought back to the board.
- d. Alma had a bid for security cameras from Platte Valley Communications/GI that she

compared to the last bid we had from Applied Connective. There were grant funds to cover the cost of the cameras and install along with replacing the EOC flat screen that is no longer working. Tom Bandur made a motion to proceed with the bid from Platte Valley Communications. Joseph Smith seconded the motion.

e. Alma explained the phone bills that have been reviewed and more will be cancelling now that we have connected to the next gen equipment.

Alma presented a bid for \$2,090.90 she received from Applied Connective to replace the desktop computer in admin office as it has been starting to fail which is the main bookkeeping and payroll computer. Jay Meyer asked about getting small battery backups for computers in office that would protect them from power outages. Wade Neben made a motion to purchase the computer with a second from Dave Larson. Ayes (10) Nays (0) Abstain (0).

Alma presented the budget for Fiscal Year 2024-2025. She pointed out the changes to the budget from the preliminary budget has finals for expenses to finish out the 2024 fiscal year which included the invoice from NIRMA for insurance that had a large deduction. Alma was informed that the EMPG grant would have a large decrease this year and was calculated into the presented budget. Alma did remind the board the increase to budget did take into account that budget was already set last year when they moved to do a wage increase after the budget had passed and also calculating wages for the new year. Two assessments were presented that was using the same formula and one with a formula with an increased base amount to include the increase wages. Tom Bandur made a motion to accept the Budget with the higher base amount in the assessment. Ayes (9) Nays (1) Abstain (0).

Communications Center Report: Statistics breakdown for the previous two months were passed out. Leak, 8 various other incidents. Total number of contacts to the Communications Center for the month of May was 3538 including 238 – 911 calls and 1435 Administrative calls into Dispatch only.

Alma reported that the new hire did not make it through the probation period and they would be advertising for dispatch.

## Director's Report:

- Disaster Declarations for Greeley & Sherman counties came through for the Arbor Day tornados that done damages in both counties. The applicant briefings were on the June 7<sup>th</sup> which was same day as another storm that done damages in all our counties except Wheeler. After doing storm assessments it was determined that Greeley sustained the most damages requiring a signed declaration due to \$250,000 in damages that Loup Valley Public Power turned in. Today NEMA informed us there was no other damages turned in from any other counties in the State for the June 7<sup>th</sup> storm that would cause them to submit a state Disaster Declaration. Alma reminded the board that the state threshold is 3.69 million for a Disaster Declaration. If there is a 72-hour period between storm damages then it starts a new time period for assessing damages for assisstance.
- Stena finish the 300/400 ICS training with the 400 class in Grand Island last week.
- Alma and Stena attended the Lou-Platte Mutual Aid in Rockville last week working on updating Mutual Aid Agreements and creating a Task Force.
- There will be a meeting this week with Riverside School to review a program for school lockdown and what it would look like for Region 26 to receive information into dispatch.

Election of Board Officers for the Fiscal Year 2024-2025:

Diana Hurlburt made a motion with a second from Dave Larson to keep the board officers the same which is Jay Meyer as Chairman, Tom Bandur as Vice-Chairman and Alma as Secretary. Ayes (8) Nays (0) Abstain (2).

Chairman Jay Meyer asked to go into executive session on personnel matters. Jack Van Slyke made a motion and a second from Joseph Smith to enter into executive session.

Executive session entered at 8:28 pm.

Dave Larson made a motion and a second from Jordan Foltz to return to regular session.

Ayes (10) Nays (0) Abstain (0). Regular session entered at 9:43 pm.

Findings: Tom Bandur made a motion with a second from Joseph Smith for wage increases for the employees to begin July 1st. Discussion as to offering the Dispatch Supervisor position to Stena if a motion needed to be made and determined it can be made in house and will be discussed at other meetings.

Other Business: Diana Hurlburt reported on what she had found out on grants. She was looking at USDA grants to see if there was anything for rebuilding the old dispatch into a garage. The USDA grant would only pay 15% and have no money in their funds currently. However, there is a Senator Deb Fischer's Appropriations grant that she found through NACO. The time frame for the grant is in April and May and would pay 80%. Diana has applied for a roads project and did say it would take a year to receive the money if funded. Diana did say it was a simple application to fill out. She had found out this was what Gage County had used for console equipment. Representative Adrian Smith also has a grant that she did not have time to look at it since it was only up for three days but would be another one to watch for.
